


In Millions

*The Revenue increase reflects improved cement sales volume and prices partially offset by lower wallboard prices.*




# Earnings Per Share

Second Quarter, In Millions




*Second Quarter wallboard sales volume up 8% and net sales prices down 10%*


# Capital Structure
