- 847 shares were withheld by the issuer to satisfy income tax withholding requirements related to the lapsing of restrictions on (a) 871 shares of restricted stock awarded to the reporting person on June 10, 2015 (Form 4 filed on 5/10/2016); (b) 859 shares of restricted stock awarded to the reporting person on 6/03/2014 (Form 4 filed on 5/7/2015); (c) 558 shares of restricted stock awarded to the reporting person on 8/12/2013 (Form 4 filed on 5/08/2014) and (d) 823 shares of restricted stock awarded to the reporting person on 6/19/2012 (Form 4 filed on 5/07/2013). Because the reporting person's restricted holdings have been included in the direct ownership Common Stock disclosed by the reporting person, the reporting person's direct ownership of Common Stock has been reduced by 847 shares to reflect this tax withholding.
